Member Eligibility

Eligibility of General Members:

Persons may be admitted as Members of the Council who meet the criteria for membership established by the Board of Directors of the Council. Requirements for membership include:

- Employment in a corporation, government agency, or non-profit organization that has a supplier diversity program or is in the process of starting one.
- The corporation/organization must proactively seek out diverseowned businesses as suppliers.
- A "supplier diversity program" means there is at least one individual charged with leading supplier diversity who proactively promotes diverse-owned supplier capabilities to supply chain management or purchasing.
- The initiative must have the tools to track and record spend that will allow the supplier diversity lead to knowledgeably set spend goals and determine capacity development needs.
